Syria: UN-mediated talks get under way; relief agencies amplify calls for access to besieged civilians.

28 January 2016 – On the eve of scheduled <u>intra-Syrian talks</u> in Geneva to seek an end to five years of internecine fighting, the top United Nations official for the war-torn country took to the airwaves today to speak directly to the Syrian people, vowing that the world organization will never abandon them.

"My message today is meant to reach every single man, woman, child of Syria, inside Syria and outside, in the refugee camps, or wherever you are," Special UN Envoy for Syria Staffan de Mistura said in a video recording.

"We count on you to raise your voice, to say khalas, it is enough, to say to everyone who is actually coming – from Syria and from abroad – to this conference that there are expectations on them to make sure that their vision, their capacity of compromise in discussion for reaching a peaceful solution in Syria is now, and they need to produce that," he said.

29 January 2016 – With United Nations-mediated talks on ending the five-year crisis in Syria getting under way today as scheduled, UN relief agencies and their partners are reiterating their appeal for unhindered access by relief workers to more than four million desperate people spread across <u>18 besieged areas</u> in the war-torn country.

Speaking to reporters in Geneva after the first set of <u>intra-Syrian talks</u>, which today featured only a Government delegation headed by the Permanent Representative of Syria to the United Nations, Bashar Jaafari and UN Special Envoy for Syria, Staffan de Mistura said that as was standard practice, a "preparatory meeting" had been held to get an idea about what the next steps will be.

"Now the issue is obviously that any type of ceasefire discussions, which is obviously something that we are aiming at, apart from substantive discussions on the future of Syria, need two interlocutors [...] that is why for us it is very important to have an indication of where we are on the presence of the High Negotiations Committee (HNC)" he said, referring to the ongoing discussions among the opposition about attending the Geneva talks.

"One of their key concerns" he said, "included the desire to see a gesture from the government authorities regarding some type of improvement for the people in Syria during the talks, for instance release of prisoners, or for instance some lifting of sieges."

#### Welcome to the United Nations. It's your world

WHO Director-General Dr Margaret Chan's statement on the first meeting of the International Health Regulations (2005) Emergency Committee on Zika virus and observed increase in neurological disorders and neonatal malformations.

"I convened an Emergency Committee, under the International Health Regulations, to gather advice on the severity of the health threat associated with the continuing spread of Zika virus disease in Latin America and the Caribbean. The Committee met today by teleconference.

In assessing the level of threat, the 18 experts and advisers looked in particular at the strong association, in time and place, between infection with the Zika virus and a rise in detected cases of congenital malformations and neurological complications. The experts agreed that a causal relationship between Zika infection during pregnancy and microcephaly is strongly suspected, though not yet scientifically proven. All agreed on the urgent need to coordinate international efforts to investigate and understand this relationship better.

The experts also considered patterns of recent spread and the broad geographical distribution of mosquito species that can transmit the virus. The lack of vaccines and rapid and reliable diagnostic tests, and the absence of population immunity in newly affected countries were cited as further causes for concern.

After a review of the evidence, the Committee advised that the recent cluster of microcephaly cases and other neurological disorders reported in Brazil, following a similar cluster in French Polynesia in 2014, constitutes an "extraordinary event" and a public health threat to other parts of the world.

In their view, a coordinated international response is needed to minimize the threat in affected countries and reduce the risk of further international spread.

Members of the Committee agreed that the situation meets the conditions for a Public Health Emergency of International Concern".

# Films showing smoking scenes should be rated to protect children from tobacco addiction

1 February, 2016: The World Health Organization is calling on governments to rate movies that portray tobacco use in a bid to prevent children and adolescents from starting to smoke cigarettes and use other forms of tobacco.

Movies showing use of tobacco products have enticed millions of young people worldwide to start smoking, according to the new WHO *Smoke-Free Movies Report – From evidence to action*, the third edition since its launch in 2009.

"With ever tighter restrictions on tobacco advertising, film remains one of the last channels exposing millions of adolescents to smoking imagery without restrictions," says Dr Douglas Bettcher, WHO's Director for the Department of Prevention of Noncommunicable Diseases.

Taking concrete steps, including rating films with tobacco scenes and displaying tobacco warnings before films with tobacco, can stop children around the world from being introduced to tobacco products and subsequent tobacco-related addiction, disability and death.

"Smoking in films can be a strong form of promotion for tobacco products," adds Dr Bettcher. "The 180 Parties to the WHO Framework Convention on Tobacco Control (WHO FCTC) are obliged by international law to ban tobacco advertising, promotion and sponsorship." **More information:**

# From Paris to the UN: Making the COP21 Agreement a Reality

Global investors are poised to step up action on climate risks and clean energy opportunities.

That was the message that came across loud and clear at the <u>2016 Investor Summit on Climate Risk: Ad-</u> vancing the Clean Trillion.

More than 500 investors came together at the UN to hear from UN Secretary-General Ban Ki-moon, Former Vice President Al Gore, Michael Bloomberg, UN climate leader Christiana Figueres, Bank of America Chairman and CEO Brian Moynihan, French Minister Ségolène Royal and leading investors on how to turn the ambitious Paris climate agreement into reality.

The support and leadership of investors is crucial to addressing climate risks and capturing the opportunities this challenge presents. Many investors are already making progress. From the launch of a new \$2 billion low-carbon index fund as part of a \$5 billion commitment to sustainable investments by New York State Comptroller Thomas P. DiNapoli, to the commitment from European pension fund ABP to quadruple its clean energy investments to 5 billion euro by 2020, to reducing the carbon footprint of investment portfolios, investors and financial institutions are moving in the right direction.

But there is still a lot of work to be done. <u>UN Secretary-General Ban Ki-moon challenged the investor community</u> to "double - at a minimum - their clean energy investments by 2020." Among the most significant investment opportunities is the electric power sector which - <u>according to a new study released by Ceres and Bloomberg New Energy Finance</u> - presents a \$12 trillion opportunity for renewable power alone over the next 25 years. This week's Investor Summit built upon, and will help sustain, momentum from last month's historic Paris climate accord. The investor community is clearly poised to accelerate a global low-carbon transition. As Secretary-General Ban Ki-moon concluded, "The once unthinkable has now become unstoppable," and the leadership of financial and investor institutions will be critical as we begin mobilizing the trillions of dollars needed to catalyze the global clean energy transition.

Recent announcements from member companies **Gap, Inc.** and **Levi Strauss and Co.** demonstrate their continued sustainability leadership among apparel sector companies. After realizing a 37% reduction in GHG emissions from its U.S. operations between 2008 and 2015, against a stated goal of achieving a 20% reduction, Gap has just committed to reducing absolute GHG emissions from globally owned and operated facilities by an additional 50 percent by the end of 2020, a science-based target aligned with limiting warming to no more than 2° C.

Through aggressive energy efficiency and other measures, LS&Co.'s Sky Harbor distribution centre in Henderson, Nevada became only the third retrofitted warehouse in the world, and the first in the apparel industry, to receive a Platinum rating from the U.S. Green Building Council's Leadership in Energy and Environmental Design (LEED) program. LS&Co.'s motivation for pursuing these facility improvements is clear: distribution centres account for nearly 40% of the company's carbon footprint.

#### Launch of SEC Sustainability Disclosure Search Tool

Ceres and CookESG Research launched a <u>new search tool</u> that will make carbon asset risk disclosures in U.S. Securities and Exchange Commission (SEC) company filings easily accessible.

The tool will allow users to find whether disclosures in annual SEC filings discuss carbon asset risks, including competition from renewable sources of energy, capital expenditures on high cost, carbon intensive exploration projects, government efforts to limit carbon emissions, and the possibility of reduced global demand for fossil fuels. It will also enable users to access to climate, water, and hydraulic fracturing risk disclosures as well as a watch list feature that allows users to track a custom list of companies.

# Footpath protest against government destruction of the lives of little kids

#### Why we are protesting:

Peter Dutton, Australian Federal **Minister for Immigration and Border Protection,** is threatening to send 72 children, currently held in Australian detention centres, back to Nauru.

Some of these children (including children in the Brisbane detention centre) have been in detention for over two years. Child psychiatrist Helen Driscoll has examined many and describes them as "extremely traumatised". They have been exposed to self-harm, sexual assaults, unsanitary conditions, lack of appropriate medical care and inadequate educational services.

In 2010 Professor Patrick McGorry described detention centres as "factories for producing mental illness". The government knows the harm they are doing to innocent people but still they are locking people up for increasingly longer times.

# Peter Dutton claims he is saving lives, but Nauru and Manus are hellholes that are slowly destroying the lives of thousands.

Preventing the transfer of these 72 children back to Nauru needs to be the first step to closing all of Australia's detention hellholes forever.

Samuel arrived into the world chubby; a miniature wrestler who, eight months on, has just produced his eighth tooth. Born at the Royal Darwin Hospital, his parents had him baptised as soon as they could and ear marked him for great things.

The dream is that their boy could become an Australian doctor or lawyer but Samuel is unlikely to realise it. He is one of 37 babies the Turnbull government wants to put on a plane, as early as next week, and send to Nauru's offshore processing centre.

Also facing the prospect of removal are around 160 adults, including Samuel's parents, and another 50-odd older children. All were brought back to Australia from offshore centres in Nauru or Manus Island, mostly for medical treatment. SMH 2 Feb 2016
