#### **United Nations Junior Professional Officer Positions**

The Academic Network wishes to draw your attention to six United Nations Junior Professional Officer (JPO) positions. The six positions are:

- UN Women in New York to work in the Office of the Deputy Executive Director;
- UN Educational, Scientific and Cultural Organisation's Institute for Statistics in Bangkok to work on education statistics:
- UN High Commissioner for Refugees in Geneva to work as an evaluation officer in the Executive Office of the High Commissioner;
- UN International Strategy for Disaster Reduction in Bangkok to work on disaster risk reduction;
- World Health Organisation in Geneva (first year) and a country office to be determined (second year) to work on health systems governance and service delivery; and
- Peacebuilding Support Office in New York to support the Peacebuilding Commission to progress recommendations of the 2010 review of the UN Peacebuilding Architecture.
