

## AUSTRALIA FACES STARK CHOICE IN THE GROWING MOVEMENT FOR A GLOBAL NUCLEAR WEAPONS TREATY Tim Wright

The recently retired UN high representative for disarmament affairs, Angela Kane, [commented in 2014](#) that a strong stigma exists for the two prohibited classes of weapons of mass destruction:

How many states today boast that they are '[biological-weapon states](#)' or '[chemical-weapon states](#)'? Who is arguing now that bubonic plague or polio are legitimate to use as weapons under any circumstance, whether in an attack or in retaliation? Who speaks of a bio-weapon umbrella?

A ban on nuclear weapons would influence not only nuclear-armed states, but also their allies, compelling those that host US nuclear weapons on their territory (Belgium, Germany, Italy, the Netherlands and Turkey) to abandon that Cold War practice. For Australia, joining the new instrument would mean ending the pretense of protection from a so-called 'nuclear umbrella'.

It is for this reason that the Coalition Government has so far resisted moves towards a ban. It asserts that nuclear weapons are necessary for our security and, indeed, our prosperity. But increasingly the logic and wisdom of that position are being challenged. A ban on nuclear weapons would influence not only nuclear-armed states, but also their allies, compelling those that host US nuclear weapons on their territory (Belgium, Germany, Italy, the Netherlands and Turkey) to abandon that Cold War practice. For Australia, joining the new instrument would mean ending the pretense of protection from a so-called 'nuclear umbrella'.

It is for this reason that the Coalition Government has so far resisted moves towards a ban. It asserts that nuclear weapons are necessary for our security and, indeed, our prosperity. But increasingly the logic and wisdom of that position are being challenged. John Tilemann, a former Australian diplomat, [wrote in March](#):

*To put unquestioned reliance in the US nuclear umbrella deprives Australia of policy flexibility and the moral right to lead efforts to fashion an alternative world order where mutually assured destruction is not the ultimate guarantor of our existence.*

Australia's negative role in disarmament diplomacy in recent years has sullied its reputation in this field. As Fairfax newspapers [reported in May](#), diplomats from pro-ban nations have labelled Australia a 'weasel state', given its membership of a group working surreptitiously to undermine disarmament efforts.

By aligning itself with NATO members, including those that host nuclear weapons, Australia has grown more and more isolated from Southeast Asian and Pacific Island states that are vocal supporters of a ban. One Australian diplomat, after participating in a regional disarmament forum in Bangkok last year, [confessed in a report to Canberra](#): '[W]e represented the lone voice in the room on many issues.'

Sooner or later, Australia's opposition to a ban will become untenable. A large majority — [84% of Australians](#) — want the government to support a prohibition. And it will eventually do so; just as it begrudgingly joined the processes to outlaw anti-personnel landmines in the 1990s and cluster munitions a decade later.

The Australian Labor Party, in its national policy platform adopted last July, [declared its support for a ban](#):

*Given the catastrophic humanitarian consequences of any use of nuclear weapons, Labor firmly supports the negotiation of a global treaty banning such weapons and welcomes the growing global movement of nations that is supporting this objective.*

[Daniel Flitton explained](#) that this position might seem unremarkable, given the 'drive to abolish nuclear weapons ever since the horror of Hiroshima and Nagasaki'. But a ban 'is something very different — and new':

*It stems from an effort by non-nuclear-armed countries in the UN, and supported by activist groups, to negotiate a treaty that would declare the very existence of nuclear weapons illegal under international law because of the catastrophic humanitarian cost, similar to the way chemical and biological weapons are prohibited. The goal is to create moral pressure on the countries with atomic arsenals.*

Last month, at a UN working group meeting in Geneva tasked with developing new legal measures for nuclear disarmament, [the momentum](#) behind the ban approach appeared unstoppable. This group will re-convene in August to finalise its report to the 71st session of the UN General Assembly, at which states are likely to adopt a resolution recommending the launch of negotiations.

Australia will face a stark choice: to join this global initiative to outlaw the most destructive, indiscriminate weapons ever created, or to side with nuclear-armed states in opposing it. The latter would potentially alienate its nearest neighbours, undermine disarmament and incite proliferation. **Lowey Institute Latest Post**

## WHO declares the end of the most recent Ebola virus disease outbreak in Liberia

**Liberia, 9 June 2016** – Today the World Health Organization (WHO) declares the end of the most recent outbreak of Ebola virus disease in Liberia. This announcement comes 42 days (two 21-day incubation cycles of the virus) after the last confirmed Ebola patient in Liberia tested negative for the disease for the second time. ## Some 13 million Yemenis need immediate help

16 June 2016 – The top United Nations relief official for Yemen has reported that more than 13 million Yemenis are in need of immediate life-saving assistance as a result of a bleak humanitarian situation in the country that continues to worsen.

"The humanitarian situation in Yemen is among the world's worst crises. The scale and intensity of the humanitarian situation here is bleak – and by many measures it's continuing to get worse," Jamie McGoldrick, the UN Resident Coordinator and Humanitarian Coordinator for Yemen, said in a press briefing in Sana'a.

"The war has taken a very heavy toll on the country and its people. It is no exaggeration to say the economy is on the verge of total collapse," he added.

## PEACE AT LAST IN COLUMBIA

A ceasefire between FARC and the Colombian government has been signed, ending 50 years of warfare. "May this be the last day of the war. We are close to a final peace accord," said Farc chief Timoleón "Timochenko" Jiménez, his voice choked with tears, after shaking hands with Colombian president Juan Manuel Santos at the signing ceremony in Havana, which was attended by the UN secretary general, Ban Ki-moon.

Although a final peace deal will require approval in a referendum, the formal cessation of hostilities between the two main combatants and the Farc's acceptance of disarmament are key steps towards resolving a low-intensity war that has caused more than 250,000 deaths and the displacement of more than 6 million people. Santos hailed a historic day for his country and its people – many of whom have only known war. 'Colombia got used to living in conflict. We don't have even the slightest memories of what it means to live in peace,' he said. 'Today a new chapter opens, one that brings back peace and gives our children the possibility of not re-living history.'" (Guardian <http://bit.ly/28TyTo6>) Guardian Graphic | Source.

## AN AUSTRALIAN FIRST BY [Sophie Vorrach on 7 June 2016](#) Queensland school installs solar and battery storage –



Schools and solar PV make a great pairing. Add storage and it can get even better. A great recent example of this can be found at **Bundaberg Christian College**. The college which already harvests and treats all of its own water and sewerage – takes sustainability seriously. Harvesting its own electricity was the next logical step. For this, the College turned to local outfit **GEM Energy**, who along with Melbourne-based inverter maker and energy management specialist **Selectronic**, designed and installed a big enough solar and battery storage system to drastically reduce the College's reliance on grid supplied electricity.

The result, pictured above, was a 194kW solar system with 250kWh of battery storage (located in the white container to the right of the water tanks), completed and switched on in March, which claims to be the largest hybrid solar and storage array ever to be installed at an Australian school.

This is not the largest solar array ever installed on a school. The honours for that achievement go to Canberra's Amaroo School, which last year commissioned a 600kW rooftop PV system; currently, they are claimed by Mazonod College in Melbourne, which installed a 270kW PV array in 2014. ## REFUGEES ARE WELCOME

In 2014 the government's own commission of audit estimated it cost \$400,000 a year to hold an asylum seeker in offshore detention

In 1984 Australia adopted a national anthem that *welcomed those who had come across the seas to share our boundless plains*. Now our political parties are saying that if you come by boat you will never be settled in Australia.

In mid-2015 the number of refugees of concern to UNHCR reached an estimated 15.1 million. The highest level in 20 years

### **No boundless plains to share**

**In 2014 the Australian Human Rights Commission** found children on Nauru were suffering from extreme levels of physical, emotional, psychological and developmental distress. Temperatures inside overcrowded tents reached 50 degrees C; water regularly ran out, toilets overflowed with sewage; phosphate dust from nearby commercial operations polluted the air; and the hospital required patients' families to supply their own linen.

The major political parties have been locked in a 'same-same, only different' policy in which they state boat arrivals will not be settled in Australia and such refugees will be processed in offshore detention centres.

**Last month** the Immigration Minister Mr Dutton upped the rhetoric by claiming the government was protecting Australian jobs by not allowing uneducated refugees into the country. "For many people they won't be, you know, numerate or literate in their own language, let alone English. These people would be taking Australian jobs, there is no question about that" he told Skye news.

"For many of them that would be unemployed, they would languish in unemployment queues and on Medicare and the rest of it so there would be huge cost and there's no sense in sugar coating that, that's the scenario."

In 2014 the government estimated it cost \$400,000pa to keep asylum seekers in offshore detentions— twice the cost of onshore detention in Australia and 10 times the cost of letting them stay in the community on a bridging or temporary protection visa while their claim is assessed. Refugee advocates claim that means the government is paying billions of dollars to detain people offshore that eventually make it to Australia.

It is an unusual situation for a nation founded by 'boat people' and whose national anthem contains the lyrics:

**For those who've come across the seas, we've boundless plains to share;  
With courage let us all combine to Advance Australia Fair!**

The only people in Australia who have not 'come across the sea' to settle in Australia, in the last 200 years, are indigenous Australians.

In *Asylum Seekers & Refugee Myths, Facts and Solutions*, the Asylum Seeker Resource Centre says asylum seekers are not illegal immigrants because immigrants leave their countries by choice and are able to return home at any time, while asylum seekers are forced to leave their homes for fear of persecution and are too fearful to return.

As for the notion that asylum seekers are queue jumpers the Asylum Seeker Resource Centre (ASRC) argues there is no just and orderly queue.

Under the Refugee Convention, even those who enter Australia by sea or plane, without a valid visa, are not illegal says the ASRC because like a speeding ambulance asylum seekers are exempt from the usual application of the law because they are in an emergency situation."

It takes five years to get on the resettlement for those who the UNHCR have already found to be refugees . Places offered through the UNHCR settlement program has remained constant, at around 80,000 world wide, so only a tiny fraction of the world's refugees have access to what is erroneously thought of as the 'proper channel'.

While both political parties have the policy of offshore detention and repelling boats, Labor is offering more humane treatment in offshore detention; fast-tracking refugee claims; and an increase in the number of refugees into Australia. Labor accuses the Coalition of having no empathy for asylum seekers while the Coalition says Labor is weak on border patrol. There is also the high level of secrecy and control that surrounds government border protection activities; the remoteness of and restricted access to the detention centres; the risk of two year jail terms for doctors and detention centre workers who speak out, means the media rely heavily on the government for information.

"The polarising nature of the debate means we have reached a stalemate." said Dr Steven Odgen, Principal Anglican Church's St Francis Theological College in Brisbane.

"This is evident from the character of public discourse, which is cast in either/or terms. In other words, it is as
