PRESIDENT'S REPORT

At the Annual General Meeting in 2005 we were fortunate to have the United States Consul Robyn McClelland as our guest speaker. Robyn spoke on her role as Consul, and her commitment to human rights ideals. In particular she focussed on the United States and their policies in Southeast Asia.

The Management Committee elected at the AGM for 2005/6 is listed on page 1 of this document.

Recognition was given to our outgoing Patron, His Excellency John Sanderson, and his excellent support to UNAA(WA). Our appreciation for his outstanding contribution towards social justice issues during his term as Governor of Western Australia was acknowledged. In particular, his speech at the 60th Anniversary Event of the United Nations, held at the WA Constitutional Centre, was noted.

PROJECTS DURING THE YEAR

Planning Day. A management planning day was held to identify the major focus for the year and the projective activities for the human rights and environment committees. A review of our management and office structure led to significant changes including the appointment of an office manager and a reduction in office opening days in response to reduced numbers volunteers. Neesha Seth undertook to carry out documentation on the specific roles of the management team to ensure seamless transition when new volunteers adopted these roles.

Lunchtime Forums

The Human Rights Committee continues to host Lunchtime Forums. In the last year 4 successful Lunchtime Forums were held:

- On 15 September we were fortunate to have the United Nations Information Centre in Sydney speak about at the Lunchtime Forum on the UN Millennium Goals.
- Anti-Poverty Week commenced on 16 October and Lisa Baker, Executive Officer
 of WACOSS (who has worked for the UN) spoke at a Lunchtime Forum on
 Monday 17 October. She spoke very well on issues of poverty in Australia and
 participated in discussion with those in attendance
- Shelter WA spoke at the Lunchtime Forum on 24 November on Housing and Human Rights.
- In April a lunchtime forum screened the documentary "Blowin' in the Wind" about depleted Uranium an issue which is slowly gathering momentum in mainstream Australia.

Approximately 60 people attended these 4 forums.

International Day of Peace

The Human Rights Committee partnered with Dr Erich Von Dietz at Curtin
University Chaplaincy to host an event for International Day of Peace on 21
September. Dr Samina Yasmeen spoke on "Human Rights, Islam and Peace."
The venue was a lecture theatre at Curtin University. Approximately 40 people attended.

John Huelin Memorial Human Rights Day Lecture

 Human Rights Day fell on a Saturday last year so we hosted this event on Human Rights Day, 10 December at 1 pm. The venue was the Alexander Library Lecture Theatre. Dr Susan Boyd presented an excellent lecture about human rights issues in Fiji. Those in attendance had the opportunity to ask questions and speak with her after the lecture, their feedback about the lecture was very positive. There was a very disappointing attendance of 25. The Department of Foreign Affairs and Trade sponsored the afternoon tea.

We have commenced planning for the John Huelin Memorial Human Rights Day Lecture for 2006. The event will be hosted on Human Rights Day, Sunday 10 December, commencing at 1:30 pm at the Alexander Library Lecture Theatre. We are delighted to announce that the Chief Justice Wayne Martin will be the guest speaker.

UN Day for the Elimination of Racial Discrimination

• The Human Rights Committee was successful in its application for a grant from the Office of Multicultural Interests for an event on 21 March, the UN Day for the Elimination of Racial Discrimination. The grant was for \$500. The event was a breakfast with a speaker discussing the origins of the UN Day in Sharpville, Africa and the experience of racial discrimination for emerging African communities in WA.

Jabu Matsebula spoke of his childhood experience of racial discrimination in South Africa, the events at Sharpville and the difficulties he experienced as a youth freedom fighter in apartheid South Africa. James Crawford spoke of his childhood in Alabama and the impact of racism and poverty on his expectations for his life and how a scholarship to college opened his eyes to other life opportunities. He also spoke of his support for marginalised young people and his work in developing "Great Mates."

The breakfast event was attended by 70 people including James Crawford, Ambassador for Harmony Week, Ms Robin McClellan, US Consul General, the Hon Margaret Quirk MLA, Tony McCrae MLA, Ms Yvonne Henderson, Commissioner of the Equal Opportunity Commission, Ms Ruth Simms, recipient of a Multicultural Community Services Award and Ms Rosemary Hudson, recipient of the 2006 Premier's Multicultural Ambassador Award. There were a

number of younger guests, including school students and members of UNYA (United Nations Youth Association).

Tertiary Model UN Conferences

Model UN Conferences (MUN) provides tertiary students with the opportunity to experience what international relations and diplomacy is really like. Students represent a Member Nation of the United Nations and debate and negotiate with other Member Nations of the General Assembly. MUN's are an authentic simulation of the debates and deliberations of UN bodies such as the General Assembly and allows University students the rare opportunity to attempt to resolve complex global issues diplomatically through role-play.

In 2006 the United Nations Association of Australia (WA) with the United Nations Youth Association and the Australian Federation for University Women organised two Model UN Conferences for WA tertiary students. The MUN were day-long conference and students from all five universities participated in this exciting new program. In Semester the first conferences was held at University of Western Australia on Saturday 29 April. The Topic of debate was 'Nuclear Proliferation'

The second MUN conference was held at Edith Cowan University on Friday 12 May. The Topic for debate was 'Terrorism'. Both events were well attended and the program is expected to rotate between WA's five universities. Acknowledgements must be made to the Australian Federation for University Women, who not only contributed funding for the events, but also participated in a meaningful way. The MUN conferences would not have been successful without the tireless work of Natalie Garcia de Heer, Tim Morris and the members of UNYA.

Thanks must go to the tireless work of Astrid Chapman, the Human Rights Committee and the contributions of Curtis Clark, Carolyne Gatward, Neesha Seth, and Lisa Hook for their ongoing contribution. Ethel Date must be congratulated on her enormous research and work questioning and articulating her concerns on the Mental Health Act. Birthe Warburg continues to write to the government and relevant agencies, questioning human rights violations. Joan Mann is active, particularly in women's issues. Astrid Chapman made an appeal to encourage members to join this committee and make a contribution.


