Resolution to National Meeting of United Nations Australia Association August 14th 2010

Subject of the Resolution:

Positive strategies to reduce the

number of Aboriginal People imprisoned in Australia.

Submitted by WA Division

The United Nations Association of Australia

RECOGNISING that the Declaration on the Rights of Indigenous people was adopted by United Nations on Sept 3rd 2007 and that the Australian Government formally supported the declaration on April 3rd 2009 is deeply disturbed at the extremely high level of Aboriginal people incarcerated in Australia

Calls on the Federal and State Governments to:

- a. Recognise that the disproportionately high levels of conflict between Indigenous Australians and the legal and justice systems has its root causes in the colonisation and dispossession of Indigenous people from land, law, language, religion and culture;
- b. Take measures to identify and communicate how this process of loss and despair is a global experience where ever Indigenous people and colonising societies now exist;
- c. Recognise that this process of colonisation and loss requires people of current and future generations who may have had no direct role in the origins of these circumstances to continue to work together towards reconciliation;
- d. Take practical and immediate action to reduce the level of imprisonment of Indigenous people that arises from non-payment of minor fines, driving infringements and compliance with basic administrative obligations;
- e. Substantially Increase funding for education and training of Indigenous people within the prison system and provide on-going mentoring and support in post-sentence programs so as to change the patterns of incarceration, hopelessness, offending and re-incarceration;
- f. Substantially increase funding of programs for Indigenous boys and girls that are a the vehicle for personal and social development;
- g. Substantially increase funding for programs that give voice and support to the elders of Indigenous communities in their work to improve the self-esteem of young Indigenous people, in providing role models and mentors and in their work to reduce substance abuse and violence.
- h. Communicate to the wider community that overcoming the effects of dispossession, marginalisation and racism experienced by Indigenous Australians will take generations of effort from us all.
