In Memoriam

Kenneth Francis Nicholas Weekes, Esquire, J.P., M.A., Dip. Ed., M.A.C.E., A.M.R.Ae.S. O.M.I.E. Aust.(Ret'd).

15th March, 1930 – 9th December, 2019 Humanist. Historian. Intellectual. World Traveller. Aeronautical Engineer. Musician. Athlete. Educationist

Kenneth Francis Nicholas Weekes belonged to the United Nations Association (NSW) from 1971 to 2019. From an early age Kenneth keenly supported the United Nations, being deeply affected by the suffering he heard about from his father who had fought in both World Wars I and II.

Kenneth had many interests. As an athlete he won awards and also played Rugby League. At 15 years he won an award as top junior bugler in Australia and later he played the organ. Always interested in other cultures, as an aeronautical engineer he worked for 4 years in London and Canada, then as a Clerk in the New York Australian Consulate. Eventually because of his mother's health he was obliged to return to Australia. After marriage he travelled more. In 1993 there was a large function at NSW Parliament House when due to his family history the Heralds of the Royal College of Arms on behalf of the Queen bestowed on Kenneth the official heraldic title of Esquire.

Kenneth gained Bachelor of Arts in the same 1996 ceremony as Charles Perkins, first Aboriginal university graduate. Kenneth next did a Diploma of Education, teaching History from 1970 to 1989, and in 1984 he gained Master of Arts with Merit, with a thesis on education in Fascist Germany.

The United Nations Association encompassed so many of Kenneth's values, for he had compassion for those suffering around the world. He enjoyed playing an active role in many UNAA activities. In Sydney he attended meetings of the Indigenous community. Kenneth even had difficulty passing a person begging without giving money. In 1983, Kenneth and Valerie, as members of Blue Mountains Branch, received a UN Peace Messenger Award from UN Secretary-General, Javier Perez de Cuellar, "In recognition of a significant contribution to the promotion of peace as set forth by the General Assembly".

When in 1992 - 3 Kenneth organised the annual Cenotaph Ceremony in Martin Place, he arranged for the UN flag to be flown on various buildings along Martin Place and revived flying the UN flag on Sydney Harbour Bridge every year. As Vice-president, Kenneth helped in the UNAA (NSW) office and assisted at and ran functions. He helped organise moving from offices in King Street, Regent Street and Humanist House.

In 1996 at the UNAA Federal Conference Kenneth received from the National Committee of the United Nations Association a Peace Award "for outstanding contribution to the cause of world peace and the advancement of humanity". The citation mentioned some of his activities including his efforts in spreading support for UNESCO (he also wrote articles which appeared in the media), the United Nations Association stalls he ran in the forecourt of Sydney Opera House, the United Nations poster displays he set up at New South Wales State Library and at the Westpac Head Office, his heading UNAA(NSW) Speakers' Panel and the Speakers' Handbook he produced, the showing of United Nations films at King Street and at the State Library's Metcalfe Theatre, his assistance to Darren Tayler in setting up the Sydney University UN Society, the well-attended lunches and dinners Kenneth organised to celebrate different United Nations dates.

Awarded Life Membership by UNAA (NSW), on the recommendation of UNAA (NSW) President, Dr Keith Suter, Kenneth was given the life title of Vice-president Emeritus of the United Nations Association (New South Wales Division), for all he had achieved while Vice-president.

Kenneth had a strong social conscience. Throughout most of his life he strove to do what he could to spread the message of the United Nations. He was one man among so many good people who strive to support those who suffer.

OUR EDUCATIONAL PROGRAM

A main focus of UNAA (NSW) is its educational programs, which are key to sustainable and durable change. This year the UNAA (NSW) was proud to launch a second and third session of its UN Diploma Program in collaboration with Williams Business College in Sydney. The Diploma is one of the ways that UNAA (NSW) is achieving its goal of promoting and celebrating the work of the UN. It helps to ensure that business leaders, academic staff, other professionals and interested members of the public are better equipped with the skills necessary to effect positive change, such as achieving the aims of the Sustainable Development Goals.

In June 2020, the UNAA (NSW) inaugurated its third session online. This session, which concludes at the end of October 2020, has been a success; more than 40 students have participated in the third session.

NEXT COURSE COMMENCING 05 FEBRUARY 2021

UNAA (NSW) will be hosting its fourth session of the UN Diploma course, which educates individuals about the history, structure, and operations of the United Nations. It imparts students with recognisable skills that can be used in either UN work or related careers.

COURSE STRUCTURE

The structure of the UN Diploma course is as follows:

- Friday night lectures: 6:00 pm 8:00 pm
- Duration: 16 weeks
- Content: Eight subjects and four competencies

The course uses Competency Based Training relating to Project Planning. Aligned with this are four assessments which will be based on the content that has been taught and assesses a student's ability to plan a project.

THE FOUR ASSESSMENTS FOCUS ON:

- Knowledge of the United Nations;
- Planning a UN function or event; and
- The student's ability to:
 - o Manage a conflict
 - o Develop and use emotional intelligence
 - o Develop a project
 - o Make a presentation

Examples of the topics covered in the course include the structure of the United Nations, the SDGs, UN peacekeeping, human rights, UN Agencies, and much more. Upon completing the course, students can become UNAA NSW Liaison Officers.

UNAA NSW SUSTAINABILITY SCHOLARSHIP

Through generous funding from the Rotary Club of Sydney Cove, which was formally signed into action on 28 February 2020, UNAA (NSW) Sustainability Scholarship was awarded to a 3rd year student studying for a Bachelor of Conservation Biology and is committed to one or more of the United Nations SDGs.

UNAA (NSW) commenced their October UN Day celebrations with their annual UN Day Wreath Laying Ceremony. Nick Kaldas A.P.M., D.Litt (honoris causa), former Deputy Police Commissioner and former Director of Internal Oversight Services in the United Nations Relief Works Agency (UNRWA), made a special address at the ceremony. The UN Day Wreath laying ceremony was a sombre reminder of the precious lives lost and sacrifices made for the protection of communities in conflict zones all over the world. Many thanks to the Event Lead, Mr Geoffrey Little, Life Member, who has assumed the position for 26 years.

UNAA (NSW) hosted their annual UN Gala Dinner, a social evening of fun and entertainment for a good cause. Organised by VP programs Ms Andrea Spencer-Cooke, the Gala Dinner was held at the NSW Parliament House with this year's Honour being awarded to Reconciliation Australia in recognition of their commitment to promoting and facilitating respect, trust, and positive relationships between the wider Australian community and Aboriginal and Torres Strait Islander peoples.

MOVEMENT MONDAY PROGRAM

UN Priorities

Throughout 2019-2020, UNAA (NSW) continued to support and promote the work of the UN and raise awareness of the UN Secretary-General's renewed priorities including: promoting peace and security to address growing geopolitical tensions; raising awareness of the climate crisis; and working to reduce global mistrust and tackle the downsides of technology through our planned program of events.

Another important focus of UN Day 2020 was commemorating the 75th anniversary of the founding of the UN, via a UN75 Exhibition detailing Australia's involvement in the UN, including in the key areas of peace and security, human rights, sustainable development and global citizenship.

New Program Framework

Peace and security, human rights, sustainable development and global citizenship are the four pillars at the heart of our Program Framework which was adopted in 2020. The framework is closely aligned with the work of the World Federation of United Nations Associations (WFUNA), and will guide our activities going forward as we aim to continue delivering a credible program of high-quality events throughout NSW.

In 2020-2021, following extensive UN75 engagement, we will be stepping up our activities and strategic partnerships in support of the 2030 Agenda to raise greater awareness and accelerate action on the global goals in NSW. 

The Director extends special thanks to President, Dr Patricia Jenkings, and VP Programs, Andrea Spencer-Cooke, for their guidance and support.

MEMBERSHIPS

UNAA NSW members are central to the success of our events, programs, and activities. We listened to our members and heard they wanted to learn about the works of the United Nations, connect with like-minded people, and discover how they can have a personal impact. In response and in addition to the existing program of events we run throughout the year, we launched our monthly Meetup which is held on the fourth Thursday of each month. We have had guest speakers including various members of the Executive Committee discuss UN Peacekeeping, UN Refugees, the UN SDGs, and the local initiatives of UNAA (NSW). Each month offers a platform for our members and volunteers to provide a "passion pitch" to share with the rest of the community the humanitarian or sustainability work they are doing. Members are the first to hear about UNAA (NSW) events and activities, and have access to member-only privileges and discounted tickets. PEACE & SECURITY

International Peace and Security is a critical function of the United Nations, as recognised in the Foreword and Article 1 of the UN Charter which identifies that the first purpose of the United Nations is "To maintain international peace and security...". It is therefore important that the UNAA (NSW) informs Australians about UN actions to maintain international peace and security and how Australia and its citizens can support and engage in such actions. This is why Peace and Security is one of the four pillars of our strategic plan, and has been the focus of more activities in 2020 as it will continue to be in the future.

This year, within the restraints of social distancing regulations, we have acknowledged critical international and national days linked to Peace and Security, such as: The International Day of UN Peacekeepers (29th May); Australian Peacekeepers Day (14th September); the International Day of Peace (21st September); and the 75th Anniversary of the United Nations (24th October). We have addressed schools; briefed on these topics at our UN Members Meetups (currently by Zoom); are developing a series of Peace Perspectives videos for the International Day of Peace; have included a presentation on peace operations in our UN diploma and UTS courses; and conduct a commemorative service annually at the Cenotaph in Martin Place for UN Day.

HUMAN RIGHTS & ENVIRONMENT

Over the past year, UNAA (NSW) has been involved in a number of activities and events to celebrate and raise awareness about human rights and the environment. Short online films of different nationalities sharing their experiences and insights of being a refugee in Australia, were shared and promoted across all of UNAA (NSW's) social channels. Further, the film IN MY BLOOD IT RUNS, directed by Maya Newell, was promoted by UNAA (NSW). It premiered on Sunday 5 July 2020 at 9:30pm on ABC and ABC iView.



COMMUNITY ENGAGEMENT

Throughout 2020, the orientation of the Community Engagement Program has been to establish a suitable values and qualities base through which to progress prospects of relational endeavour in the context of a proposed statement of Universal Ethos for the Sustainable Development Goals (SDGs).

UNAA (NSW) has engaged in numerous community engagement events such as at the University of New England February in 2020 'Rethinking Peace, Conflict and Governance Conference' leading to the International Network of Museums for Peace Conference in September 2020.

The foregoing and further endeavours for the Community Engagement Project Program will proceed through its new Four Pillar Strategy, and more specifically its UN Global Citizenship Pillar, incorporating Culture and Society elements.

UN YOUTH (NSW)

UN Youth NSW has engaged and educated over one thousand students in 2019/2020 through its suite of educational programs and competitions for high school students centred on issues of national and international importance, with an emphasis on diplomacy, politics, international relations.

In August 2019, UN Youth NSW ran its still relatively new Negotiations Competition allowing 64 Years 10–12 students who were tasked with conflict resolution and consensus building in fictional diplomatic geopolitical disputes. Its September 2019 Junior Leadership Weekend residential conference for Years 7–8 students educated over 100 students on gender equality. The theme 'Putting Gender on the Agenda' had an emphasis on advocacy and becoming change-makers in our local communities. Over 200 metropolitan and regional students competed in its 'Voice' public speaking competition in October–December 2019 where they pitched innovative solutions to pressing global issues.

In early March 2020, UN Youth NSW held perhaps its biggest ever State Conference, their flagship weekend residential leadership event, for over 200 Years 9–12 students. The theme of State Conference 2020 was 'The Politics of Development". In June 2020, they ran their 'Evatt' model United Nations Security Council debating and diplomacy competition online using Slack and Zoom and engaged over 250 students in this state-wide competition. In 2019/2020, they also conducted a number of school visits and day summits on various topics of international importance and international relations, such as the need for free and independent journalism across the globe.

BLUE MOUNTAINS

The Blue Mountains branch of UNAA (NSW) continues to maintain a practical demonstration of urban permaculture and home forest-food gardening. The goal is for increasing numbers of home yards throughout the world to emulate the example. Our aims align with the UN's Sustainable Development Goals.

The garden is on a small area belonging to a three-bedroom rented flat and it displays on the front and side garden, 22 fruit and nut trees with an understory of herbs, vegetables, and medicinal plants.

Emphasis is placed on the importance of 'Sense of Humus' composting which takes place in five hygienic, aerobic, conical shaped compost bins, all made from 100% recycled plastic. Also displayed in the garden are what we call Mind-Vitamin Thought-Seeds which are laminated placards affixed to tomato stakes, all containing simple wise quotes designed to inspire, educate, and motivate.

Notes to the Financial Statements For the Year Ended 30 June 2020

Note 1: Summary of Significant Accounting Policies

The financial statements are special purpose financial statements prepared in order to satisfy the financial reporting requirements of the Associations Incorporation Act 2009. The committee has determined that the association is not a reporting entity.

The financial statements have been prepared on an accrual basis and are based on historical costs and do not take into account changing money values or, except where stated specifically, current valuations of non-current assets.

The following significant accounting policies have been adopted in the preparation of these financial statements.

a) Revenue and Other Income

Interest revenue is recognised using effective interest method, which for floating rate financial assets is the rate inherent in the instrument.

Grant and donation income is recognised when the association obtains control over the funds, which is generally at the time of receipt.

If conditions are attached to the grant that must be satisfied before the association is eligible to receive the contribution, recognition of the grant as revenue will be deferred until those conditions are satisfied.

b) Accounts Payable and Other Payables

Accounts payables and other payables represent the liability outstanding at the end of the reporting year for goods and services received by the association during the reporting year that remain unpaid. The balances are recognised as a current liability and the amounts are normally paid within 30 days of recognition of the liability.
