



## **OUR VOLUNTEERS**

The UNAA (NSW) has continued to attract significant interest in volunteering over the past year. Our platform has more than doubled over the last 12 months to over 1200 registered supporters who expressed interest in volunteering with us. This is attributed to implementing a fully online and selfpaced volunteer process and shifting our approach from being event-driven and Sydney-centric to focus on projects that meet each volunteer's skills, interests, availability, and location across NSW.

#### **KEY HIGHLIGHTS OVER THE PAST 12 MONTHS INCLUDE:**

- Supporting our internal structure and teams, such as our four Pillars, Marketing, and primary projects
- Delivering projects for International Women's Day, International Day of Education, NAIDOC Week, International Youth Day, World Social Work Day, and International Day of Yoga
- Establishing partnerships with Singularity U Australia, Dress for Success, The Women's Resilience Centre, Heartfulness Institute Australia, The Executive Centre, and Edu-fy
- Developing a process to support interns to complete remote and project-based placements, including from Australian Catholic University, University of Sydney, University of Western Sydney, and Caringbah High School
- Developing a Volunteer Data Dashboard to better manage our volunteers
- Raising funds by walking 608km for UNICEF Australia's Water Walk Challenge
- Participating in the Refugee Walk by UNHCR and OneStep
- Being requested to coordinate volunteers for the large-scale Ocean Lovers Festival in November at Bondi Beach
- Developing processes and resources to better support volunteers.

Our plans for 2021/2022 include developing a strategy to better align our members and volunteers, strengthening our Internship Program across the Four Pillars, and developing a guide to using the UNAA (NSW) logo on social media.



## **OUR EDUCATIONAL PROGRAM**

Education about the United Nations and its activities empowers learners of all ages with the knowledge, skills, values and attitudes to address the interconnected global challenges we are facing, including climate change, environmental degradation, loss of biodiversity, poverty, and inequality.

The UNAA (NSW) is committed to preparing students and learners of all ages across Australia to find solutions for the challenges of today and the future. Education should be transformative and allow us to make informed decisions and take individual and collective action to change our societies and care for the planet.

### THE UNITED NATIONS CENTRE FOR EDUCATION

During 2020/2021 the UNAA (NSW) established its United Nations Centre for Education (UNCE), as a part of its goal to help Australia achieve Sustainable Development Goal 4: Quality Education, and it is considered a driver for the achievements of all 17 SDGs.

The UNAA (NSW) UNCE is a platform aimed to provide the knowledge, skills, attitudes, and values necessary to address sustainable development challenges across Australia and beyond.

## THE UNAA (NSW) UN Diploma

As part of our overall Education Program, our very highly successful UNAA (NSW) UN Diploma, in collaboration with Williams Business College. This course helps to ensure that business leaders, academic staff, other professionals, and interested members of the public are better equipped with the skills necessary to effect positive change, such as achieving the aims of the SDGs.

Over the course of 2020/2021, the UNAA (NSW) held 2 online sessions. To date we have inspired and engaged over 150 individuals across Australia, giving them the opportunity to become UNAA (NSW) Liaison Officers.

#### THE UNAA MODULAR SERIES WITH UTS

The UNAA (NSW) collaborated with the University of Technology of Sydney (UTS) in the course of 2020 to create their inaugural online education program, the UN Modular Series, an in-depth online short course over five weeks on the key aspects and elements of the United Nations. The outcome of this course enabled students and working professionals to understand the structure of the United Nations, its operations, and its impact on the world.

## THE UNAA (NSW) SCHOOL PROGRAM

The UNAA (NSW) has built its inaugural 'United Nations Day ~ Peace People Planet' initiative to promote awareness in schools of the work of the United Nations and the 2030 Agenda for Sustainable Development and to gain their support for the UN mission. To date, 20 schools in NSW are participating in this program.

Educational institutions can get involved on multiple levels by incorporating various events and activities such as wearing blue to raise awareness on United Nations Day, running 'Creativity for the Sustainable Development Goals' art competitions, holding a United Nations Day section in assembly, and by integrating some of our UN resources into the classroom.

### THE UNAA (NSW) LIFE EDUCATION PROGRAM

The UNAA (NSW) Human Rights team has established a partnership with Life Education and the Department of Education to conduct a 'Schools Competition'. This inaugural program focuses on primary schools in NSW, where students are to submit art and written expressions on the topic of "the Rights of the Child".

### UNIVERSITY OF SYDNEY INDUSTRY AND COMMUNITY PROJECT

Over four weeks in June and July 2021, UNAA (NSW) partnered with the University of Sydney as part of their interdisciplinary Industry and Community Project program. A total of 44 University of Sydney students from Arts, Business, Science, Conservatorium of Music, Architecture Design and Planning, and Law came together to work on the project topic "Quality Education for All". Students worked in interdisciplinary groups to come up with recommendations and solutions for how to design a program that advanced SDG 4: Quality Education in Australia.

A number of fantastic presentations were made to UNAA (NSW) that explored different aspects of SDG 4 and drew on key development priorities in Australia, including parity in mathematics education, lifelong learning, parity in education, and education for sustainable development. UNAA (NSW) was pleased to collaborate with the University of Sydney and engage young Australians in the Sustainable Development Goals.





## **PEACE & SECURITY**

The focus of the Peace and Security Pillar is to raise awareness of the UN's crucial role in maintaining peace and security around the world and to enable a safe and peaceful Australian community. It supports the objective of SDG 16 "to promote peaceful and inclusive societies for sustainable development," which is a key foundation for achieving other goals.

The team has been active throughout the year on a community level, stressing the role that the United Nations undertakes to maintain peace and security around the world and emphasising the important role of all Australians to contribute to a safe and peaceful Australia.

### INTERNATIONAL DAY OF PEACE

To commemorate the International Day of Peace, UNAA (NSW) representatives attended the Australian Peacekeepers Day commemoration at the Australian Peacekeeping Memorial in Canberra on 14<sup>th</sup> September and also participated in the development of the International Day of Peace 'Peace Perspective Videos' to showcase the contribution of Australia's most important promoters of peace and celebrate Australia's unique perspectives on Peace. This project was a collaboration with the Rotary Club of Sydney Peacebuilding Group and Know My Group.

#### INTERNATIONAL DAY OF LIVING TOGETHER IN PEACE

On 16th May the UNAA (NSW) Vice President (Ops) and former Military Adviser of UN Peacekeeping Tim Ford AO, connected with the citizens of Wagga Wagga to commemorate the International Day of Living Together in Peace by joining with the Multicultural Council of Wagga Wagga and key individuals of the region to conduct a very successful panel discussion.

Stakeholders include: Geraldine Rurenga, incoming Rotary District Governor for some 90 clubs in the region; Yapa Bandara, Chair of the Multicultural Council of Wagga Wagga; and Jan Roberts, women's rights activist and a founder of the Wagga Women's Health Centre.

#### INTERNATIONAL DAY OF UN PEACEKEEPERS

The International Day of UN Peacekeepers is commemorated yearly on 29th May to honour the memory of UN peacekeepers who have lost their lives and pay tribute to those who serve in peacekeeping operations. This year, the UNAA (NSW) conducted an art competition to highlight this day.

The concept was to create a piece of art that demonstrated support for the role and actions of UN peacekeepers around the world. Top entries included poems, drawings, paintings, photographic portraits, videos, and songs.

The winning entry was a drawing by Yasmine Yakushova, which tells the story of UN peacekeepers interacting with the local community in their mission area.

### **UNITED NATIONS 75TH ANNIVERSARY**

2020 marked a significant milestone—the 75th anniversary of the founding of the United Nations. Our special UN75 celebrations commenced on Friday 23rd October 2020 with our traditional UN Day Commemorative Wreath Laying Ceremony at the Cenotaph in Martin Place, Sydney.

Held under very different social distancing procedures and restrictions due to the COVID 19 pandemic, the service was once again successfully coordinated by Event Lead and Life Member, Mr Geoffrey Little, who has been the organiser for 27 years. Her Excellency the Honourable Margaret Beazley AO QC, Patron of UNAA (NSW) and Governor of New South Wales, gave a special address. Other notable guests included Mr Warren Mundine AO and Senator Major General Andrew James Molan, AO, DSC. This Ceremony appropriately recognised those who have laid down their lives in the service of peace and for the protection of communities in conflict zones all over the world.

Australia's 75 years of involvement in the UN was also celebrated through a hybrid live/online UN Day event held in partnership with the Department of Foreign Affairs and Trade NSW (DFAT NSW) and Multicultural NSW. Master of Ceremonies and SBS presenter, Janice Petersen, facilitated a high-level panel discussion featuring eminent guest speakers, including the CEO of Multicultural NSW, Joseph LaPosta, Elizabeth Evatt AC, Adam McCarthy, the Assistant Secretary International Organisations Branch of DFAT, and David Hirsch, Chair of Rotary Club of Sydney Peacebuilding Group.

During the broadcast, the UNAA (NSW) 2020 UN Day Honour recipient Sam Mostyn AO also delivered her keynote acceptance speech. The award recognises her efforts to advance the principles of sustainable development, as defined by the UN, and leadership in the area of diversity and inclusion in Australia.







UN Day 2020 also marked the launch of the UNAA (NSW) virtual UN75 Exhibition staged in collaboration with Google Arts and Culture, DFAT (NSW) and Multicultural NSW. This engaging ongoing online exhibition showcases the untold story of Australia's involvement in the United Nations since 1945. Featuring five story themes and over 85 striking images from our partners and UN Photo, all Australians can now discover how Australia has actively shaped the United Nations and many of the universal international standards applied throughout the world today.

## **UN 75 CALL TO ACTION**

In January 2020, the United Nations launched a global consultation to mark the 75th anniversary of the United Nations. This initiative is the world's largest conversation about current global challenges and the future we are headed towards. Through surveys and dialogues, people from all walks of life were asked about their hopes and fears for the future, their priorities for international cooperation and for the United Nations in particular. Since then, over one million respondents from all UN Member States and Observer States have taken part in the consultations, with the following results:

## **KEY PRIORITIES for POST-COVID recovery:**

HEALTH ACCESS TO BASIC SERVICES. Improving access to basic services: healthcare, safe water and sanitation, and education

GLOBAL SOLIDARITY. Greater international solidarity and increased support to the places hardest hit by the pandemic. This includes tackling poverty, inequalities and boosting employment.

INCLUSIVE ECONOMY: the need for greater inclusion of civil society, women, youth, vulnerable groups, cities and local authorities, businesses, regional organisations and other international organisations.

## **LONGER-TERM PRIORITIES:**

CLIMATE CHANGE. The future impact of climate change. Our inability to stem the climate crisis and the destruction of the natural environment is viewed by respondents as the most overwhelming medium and long-term concern

**POVERTY.** Ensuring access to education and women's rights will improve

GOVERNMENT CORRUPTION. Ensuring greater respect for human rights, settling conflicts, tackling poverty and reducing corruption

CONFLICT/ VIOLENCE. International cooperation is vital to deal with today's challenges. The majority of respondents believe the COVID-19 crisis has made international cooperation even more urgent.

### INTERNATIONAL HUMAN RIGHTS DAY

The 72nd Anniversary of the signing of the Universal Declaration of Human Rights saw the UNAA (NSW) staff and volunteers participate in a visit to the Sydney Jewish Museum which documents the Holocaust, the history of the Jewish people in Australia, and explores human rights issues in Australia. Volunteers also distributed Declaration Booklets around local councils to promote what is a landmark document.

Once again, many thanks to Lendlease for turning the International Towers blue in acknowledgment of this most important anniversary.



### INTERNATIONAL **WOMEN'S DAY**

The UNAA (NSW) proudly partnered with Dress for Success Sydney to celebrate International Women's Day 2021. Together, we set a target of raising funds by donating 1 hour pay to Dress For Success' Empower Hour fundraiser. By achieving this target, this project will transform a woman's future with six months of one-on-one career coaching, resources for a job interview, and of course a killer outfit from head to toe.

The UNAA (NSW), its members, and volunteers, also showed their support by participating in the online campaign #WomenInLeadership by posting photos of members and volunteers online with the #SDG5 and #GenderEquality hashtags and expressing what changes they would like to see for an equal future.

Finally, the UNAA (NSW) in partnership with Affinity Intercultural Foundation and the Journalists and Writers Foundation, hosted an online event to discuss 'Walking Together: Australian Indigenous Women's Perspectives and Insights in their Journey of Leadership' in honour of International Women's Day with the United Nations Commission on the Status of Women in New York (NGO CSW/ NY).

The aim of this forum was to share the unique challenges, resilience, and vision experienced by indigenous female leaders shaped by their community, culture, and history.

#### HARMONY DAY

To celebrate Harmony Day which coincides with the United Nations International Day for the Elimination of Racial Discrimination, the UNAA (NSW) hosted a dedicated online UNAA Members and Volunteer's Meetup event. This day celebrates Australian multiculturalism, based on the successful integration of migrants into our community. It is about inclusiveness, respect and belonging for all Australians, regardless of cultural or linguistic background, united by a set of core Australian values.

Guest speakers included Chin Tan, Race Discrimination Commissioner of the Australian Human Rights Commission and Mariam Veiszadeh, Members & Advisory Director of the Diversity Council of Australia.



## SUSTAINABLE DEVELOPMENT

The focus of the Sustainable Development Pillar is to promote a sustainable and resilient future for people and planet, where the needs of the present are met without compromising the ability of future generations to meet their own needs. Its focus is to raise awareness of the 2030 Agenda and support the Australian community to take climate action and transition to net zero carbon emissions by 2050.

The UNAA (NSW) has a team of passionate and dedicated individuals who are focused on the SDGs to have a measurable impact in Australia. We are adopting the Collective Impact framework to act as a backbone organisation for Corporates, Government agencies, and Non-profits to work together to advance the SDGs.

The start of 2021 marked a wonderful occasion in welcoming a fresh, talented group of people to the Marketing and Communications team. Marketing and Communications is critical to the UNAA (NSW) purpose; to inform, inspire, and engage Australians to create a safer, fairer, more sustainable world.

#### The team has focussed on:

- Creating more regular, engaging content (such as our Motivation Monday and Feel Good Friday posts)
- Launching a new UNAA (NSW) website
- Heavily promoting the UNAA (NSW) UN Diploma
- Educating our followers about UN and national days (such as NAIDOC Week and World Environment Day)
- Supporting the various events and campaigns that UNAA (NSW) runs (including our World Health Day event, the Global Citizenship Annual Gathering, meetups, and more).

Facebook continues to be the platform with the most engagement. From 1st November 2020 to 30th June 2021, we welcomed 388 new Facebook page likes (now a total of 2,879 likes) and increased our Facebook Page Reach by 42%. LinkedIn is becoming a more responsive platform, due to our increase in engaging content. We now have 6,471 followers. From 1st January to 30th June 2021 reactions increased by 67%, comments increased by 54%, and shares increased by 200%.

**Notes to the Financial Statements** For the Year Ended 30 June 2021

#### **Note 1: Summary of Significant Accounting Policies**

The financial statements are special purpose financial statements prepared in order to satisfy the financial reporting requirements of the Associations Incorporation Act 2009. The committee has determined that the association is not a reporting entity.

The financial statements have been prepared on an accrual basis and are based on historical costs and do not take into account changing money values or, except where stated specifically, current valuations of non-current assets.

The following significant accounting policies have been adopted in the preparation of these financial statements.

#### a) Revenue and Other Income

Interest revenue is recognised using effective interest method, which for floating rate financial assets is the rate inherent in the instrument.

Grant and donation income is recognised when the association obtains control over the funds, which is generally at the time of receipt.

If conditions are attached to the grant that must be satisfied before the association is eligible to receive the contribution, recognition of the grant as revenue will be deferred until those conditions are satisfied.

#### b) Accounts Payable and Other Payables

Accounts payables and other payables represent the liability outstanding at the end of the reporting year for goods and services received by the association during the reporting year that remain unpaid. The balances are recognised as a current liability and the amounts are normally paid within 30 days of recognition of the liability.


